*The survey process was managed by the Best Companies Group, and the ranking was determined by ModernThink LLC. A two-part assessment process was used. The first part of the assessment consisted of the ModernThink Infrastructure and Practices Inventory (employer questionnaire<one-third of the overall score), which captured important information about policies, practices and demographics for each company. Part two consisted of the ModernThink Insight Survey (employee survey<two-thirds of the overall score) through which ModernThink evaluates the overall workplace experience from the employees' point of view. The scores were combined to determine the final ranking.
